Members will also learn about improvements, new features, and future changes to the Dimensions program.

February 21: Frailty and Palliative Care: Caring Across the Continuum Event - In-Person

On Friday, February 21, 2020, join your colleagues in Deadwood to facilitate communication and cultivate collaboration among South Dakota health care providers. Participants will learn how to identify the medical risk of a patient, their vulnerability to adverse outcomes and the appropriateness of their goals and expectations, through the evidence-based metric, frailty. Frailty is the best metric for determining risk thus framing a truly person-centered plan of care. As a patient's frailty becomes more severe, it is important for clinicians to deliver palliative care focused on relief of discomfort and optimal quality of life. There will be an overview of palliative care and interventions and impacts across the continuum will be discussed. In closing, participants will engage in an open dialogue with the presenters and their colleagues on the topic of frailty and palliative care.

January 16: Accountability Within Your Organization - Webinar



January 23: 211 University - Webinar

January 28: Supporting the Caregiver Through Stress Management Strategies - Webinar

Health care team members have often referred to the family caregiver as "the second patient." This course reviews the significant burden of stress facing the caregiver and its correlation to the resident receiving care by the health care team. Strategies will be shared for the health care team member to support the caregiver, to include a range from verbal feedback to recommendations for managing the stress so that they can better care for their own physical, mental and emotional health.

January 30: Solutions to Lower Extremity Wounds - Webinar

Impaired circulation and bony deformities make lower extremity wounds difficult to heal and recommended interventions are often rejected. This webinar evaluates treatment of arterial, pressure-related, edema-related and neuropathic wounds of the lower leg, ankle and foot and provides an updated look at products and treatments that help with healing.

January 30: Ligature Risk and Suicide Prevention Regulation - Webinar


Hospitals must comply with CMS conditions of participation (CoPs) or face penalties. According to CMS and accrediting organizations such as Der Norske Veritas and The Joint Commission (TJC), one of the most commonly cited deficiencies at the immediate jeopardy level is about the rights of patients to receive care in a safe setting. According to CMS, ligature risks compromise a patient's right to receive care in a safe setting. The hospital's responsibility to provide care and safety to psychiatric patients at risk of harm to themselves or others is one of CMS' primary concerns. This webinar will explain the specific guidance surveyors use to determine compliance with providing care in a safe environment.

February 13: Commonly Cited Deficiencies for Critical Access Hospitals - Webinar

Critical access hospitals are required to comply with CMS conditions of participation. There are commonly cited deficiencies during standard surveys and complaint investigations of critical access hospitals. This presentation identifies the top-cited regulations and explains the regulation and why they are found noncompliant.
