Her film, Caregiver: A Love Story won Best Documentary Short at the San Francisco Jewish Film Festival.

Over many years, Ruth's group initiated and led programs, surveys, and initiatives, including serving as the initial lead on CLASS implementation (and the lead on its conclusion), the Cash and Counseling Demonstration (the first consumer directed longterm care program), the only nationally representative survey of CNAs, the caregiver supplement to the National Health and Aging Trends Survey, and the development of a model for estimating participation in and costs of long-term care reform proposals.
