This journey becomes even more perilous as hospitals struggle to transition their delivery and payment systems simultaneously and must decide whether to affiliate or continue to operate independently. In his presentation Future of Rural Healthcare: Strategies for Success, Stroudwater Director Eric Shell takes an in-depth look at the industry as a whole and at the particular struggle faced by rural and community hospitals, and outlines strategies for these facilities to not only survive, but thrive in the fast-approaching era of population health. This presentation is a valuable tool for healthcare leaders seeking the best strategy to guide their facilities across the "shaky bridge" from fee-for-service to reimbursement based on value and quality.

The American College of Surgeons (ACS) STOP THE BLEED® program is administered by the ACS Committee on Trauma (ACS COT). The ACS COT, formed in 1922, has put forth a continuous effort to improve care of injured patients in our society. Today trauma activities are administered through an 86-member committee overseeing a field force of more than 3,500 Fellows who are working to develop and implement meaningful programs for trauma care in local, regional, national, and international arenas. With programs such as its STOP THE BLEED® Course, the COT strives to improve the care of injured patients before, during, and after hospitalization. The STOP THE BLEED® campaign was initiated by a federal interagency workgroup convened by the National Security Council Staff, The White House.

Changes are coming to South Dakota Medicaid in 2023! During this session, the Department of Social Services will provide updates on Medicaid expansion, eligibility, and other upcoming changes.

9:15 - 10:15 am | A Collaborative Approach to Manage Hospital to Nursing Home Transitions | Nita Dunham, MS, RN, CMAC, CDP, Systems Director of Case Management, Monument Health

Transitions can be challenging for patients who meet the criteria for nursing home placement, whether the patient is in need of a short-term or long-term stay. The organization highlighted in this session was faced with hospital capacity issues and patient flow challenges that were further impacted by a 19.3% readmission rate for this population. This necessitated case management partnering with the providers, multidisciplinary team and community facilities to coordinate individualized patient plans with a focus on safe transitions. In this session, you will learn key strategies to implement a community Geriatric Forum Collaborative that can be utilized in multiple health care settings that leverages the electronic medical record, standardized expectations and regulatory compliance for both hospitals and nursing homes.

Congress is considering legislation on a number of issues that affect hospitals and their communities. This session will provide an update from policy makers in D.C. on the status of current legislative efforts in Congress to address issues of concern to rural health providers as well as an update on the outlook for Medicare and Medicaid policy changes that affect hospitals.
