**Why should you attend:** The No Surprises Act provides both insured and uninsured people with important rights and protections relating to medical bills. We'll share how to use the <u>new CMS Medical Bill Rights website</u> and answer your questions. You'll learn:

- how uninsured people can get a Good Faith Estimate and prevent over-charges;
- when the new law prohibits certain out-of-network providers from sending a surprise bill;
- how to use the "action plan" tool that helps patients exercise their rights and find a resolution if they receive an unexpected medical bill; and
- how to submit complaints or get answers at the No Surprises Help Desk; and more!
