


THROUGHPUT SURVEY REPORT APRIL 2024

The South Dakota Association of Healthcare Organizations (SDAHO) has been hearing from members about the challenges they face in placing patients in post-acute care beds across the state. SDAHO staff have worked with peers in other states, primarily Nebraska and Minnesota, to develop a survey to collect data measuring the impact this is having across South Dakota. A total of 24 hospitals participated in the April survey, with 7 stating they had at least one patient who had been ready to discharge for seven days or longer but was still awaiting discharge. Delays in placing patients impact both the patients and the provider community, creating financial hardships and impacting quality of life. The goal of producing this survey is to help show policy makers, government leaders, and the public the impact this is having on hospitals, post-acute care providers, and patients across South Dakota. Patients Awaiting Discharge > 7 Days in SD Hospitals






Patients with dementia or behavioral needs often have an extended stay, there are very limited memory care options. We recently had to place a patient in their 60s at a facility in Iowa 6 hours away from family as we couldn't find any placement in South Dakota.

Very difficult to place young patients with medical history of traumatic brain injuries.

Patients Awaiting Discharge Requiring Specialized Care




On average it costs a hospital \$1,000 per day to care for these patients. The estimated impact at the time of the survey was \$1.70M.
