Enabling Skilled Nursing and Assisted Living Operations to Thrive in Value-Based Partnerships | *Samantha Vosloo & Ian Strand, PointClickCare* | As the healthcare landscape shifts towards value-based care, skilled nursing and assisted living operators are increasingly seeking strategic partnerships with risk-bearing entities to enhance clinical capabilities, improve outcomes, and unlock financial opportunities. This presentation explores how operators can align with Medicare Advantage plans, ACOs, and other risk-sharing models to elevate care delivery while capturing shared savings.

We will discuss how integrating advanced care management tools, AI-driven risk stratification, and real-time data exchange can enhance clinical decision-making, reduce avoidable hospitalizations, and optimize reimbursement. Additionally, we will showcase how gainsharing arrangements incentivize better patient outcomes and drive financial sustainability for post-acute operators.

A Comprehensive Overview of Updated Infection Control and NHSN Requirements for Long-Term Care | *Jess Danko, MS, RRT, LTC-CIP. & Lori Hintz, RN, CADDCT, South Dakota Foundation for Medical Care* | On February 24, 2025, significant updates to the Long-Term Care Surveyor Guidance (Appendix PP) and the State Operations Manual (SOM) came into effect. This session will provide a detailed overview of the infection control-related revisions, along with an examination of NHSN reporting requirements for F884 compliance and the SNF Quality Reporting Program. Attendees will gain practical tips and access to valuable resources to better understand and implement these updates effectively. *CE: NHA, SW*

Cassie Deffenbaugh, Diana Weiland, and Jen Maeschen will offer valuable insights and recommendations, covering the most common deficiencies cited in surveys, top complaints against providers, and the latest regulatory guidance. They will also share effective tips and best practices for avoiding frequently cited deficiencies and enhancing care and safety for those served. State Strategies to Revitalize the Long-Term Care Workforce | *Sean Slone, Council of State Governments* | Since 2022, the Council of State Governments (CSG), supported by The Commonwealth Fund, has led projects to address the long-term care workforce crisis. Focusing on strategies such as increasing compensation, enhancing training, expanding the workforce pipeline, and supporting family caregivers, CSG identified effective state-level solutions. In this session, Senior Policy Analyst Sean Slone will share key findings from these projects, including policy examples from states like Hawaii and Pennsylvania. He will discuss how addressing the workforce crisis requires coordinated action across all levels of government and diverse stakeholders. *CE: NHA, SW*

Drug Diversion – Don't Be A Willing Participant | *Dana Darger, RPh, Monument Health* | This session will cover key strategies for preventing, detecting, reporting, and training staff on drug diversion. The Data Doesn't Lie: The Truth About the Current State of Employee Well-being | *Jean Hartnett, Radical Sabbatical* | Leaders across the long-term continuum share the same challenge of retaining employees. This presentation will provide ground-breaking research and a unique perspective not often considered when managing, leading and retaining team members. Participants will gain an understanding of the prevalence of trauma among the workforce, the impact of the COVID-19 pandemic on physical and mental health and challenges associated with social determinants of health. Armed with this data, leaders will leave the session with a fresh perspective on what employees face in their everyday lives and what leaders can do to support them in their organizations. *CE: NHA, SW*

Assisted Living Centers – Changes and Trends | *Shelly Walstead, RN, South Dakota Department of Health* | Staying up-to-date with the rapidly evolving landscape of assisted living regulations can be a challenge. Join Shelly Walstead, RN and Public Health Advisor, as she provides valuable insights into recent regulatory updates and shares key observations from health facility surveyors during licensure and complaint surveys. *CE: NHA, SW*

The QRP Penalty: Just a Little Off the Top | *Jessie McGill, RN, BSN, RAC-MT, RAC-MTA, American Association of Post-Acute Care Nursing* | A little off the top, like an unfortunate haircut, can be more detrimental after stepping back and looking at the full impact. The Quality Reporting Programs (QRP) for skilled nursing facilities and home health agencies require the reporting of specific data elements to maintain compliance. If providers fail to report the required information, they are faced with just a little cut off the top, a 2 percent cut to their Medicare annual payment update (APU). While this cut may seem small, it can result in a substantial loss to providers' reimbursement. Join AAPACN Sr. Curriculum Development Specialist, Jessie McGill, RN, BSN, RAC-MT, RAC-MTA, to discuss strategies to achieve compliance with the QRP and establish systems for quality improvement in the QRP measures. *CE: NHA, SW*

The Changing Landscape of Medicare: Home Health and Hospice | *Katy Barnett, LeadingAge* | In recent years, care in the home has been championed at every level of government but both home health and hospice have faced backlash for higher costs, bad actors, and industry-wide consolidation. In this session, Katy Barnett will share an update on Medicare payment and regulatory policies that shape the ability of Medicare providers to care for older adults in their homes. She will the massive regulatory changes coming to the Medicare home health and hospice programs in 2025 and how to effectively prepare. She will also brief participants on federal regulatory advocacy efforts related to benefit reform, program integrity, and payment. *CE: NHA, SW*

A Pie Eating Contest: Why Care Plans Get Messy | *Jessie McGill, RN, BSN, RAC-MT, RAC-MTA, American Association of Post-Acute Care Nursing* | Pie anyone? It seems like an easy question, with an easier response (yes, please!), but it really is not that simple.
