

**From Surviving to Thriving: Strategies to Eliminate Toxic Workplaces** | Jill Weisensel | CE: LNHA, SW, CDM/CFPP

From Surviving to Thriving: Strategies to Eliminate Toxic Workplaces equips post-acute care professionals with practical strategies to address difficult workplace behaviors and build stronger team relationships—regardless of role or title. This session explores common contributors to toxic work environments, including unclear expectations during busy shifts, unaddressed conflict, and harmful behaviors such as gossip, exclusion, dismissive communication, and inconsistent accountability. Participants will gain realistic tools for speaking up respectfully, setting healthy boundaries, supporting coworkers during stressful moments, and protecting their own well-being amid heavy workloads and constant change, leaving with actionable skills they can immediately apply to improve teamwork, communication, and patient care.

**Quality Assurance Performance Improvement: Required Compliance - Real Results** | Debbie Rayburn | CE: LNHA, SW

While QAPI is a regulatory requirement across several licensed care settings, too often it remains a box-checking exercise that yields little beyond basic compliance. This session introduces the fundamentals of QAPI across care settings, with a focus on harnessing the basics to make meetings purposeful, drive actionable plans, and achieve measurable improvements in care quality. Practical strategies will be shared to help teams move beyond compliance and toward meaningful outcomes that enhance resident and patient experiences.

**SNF Regulations and Surveys: Recent Developments and Trends** | Sean Fahey | CE: LNHA, SW

Regulatory changes and survey trends impact all skilled nursing facilities (SNF) across the nation. This session will review and evaluate significant regulatory developments from the past year. The presenter will provide updates on the minimum staffing standards and other long-term care regulations. He will also identify current survey trends by reviewing the top survey citations issued regionally and nationally. Throughout the session, participants will be encouraged to discuss common regulatory challenges in skilled nursing and share best practices related to regulatory developments and survey trends.

**Enhancing the Dining Experience in Long-Term Care** | Scott Eisenbeisz | CE: LNHA, SW, CDM/CFPP

A positive dining experience is central to quality of life in long-term care. Beyond providing nutrition, mealtimes offer opportunities for dignity, social connection, and enjoyment. This session explores approaches to transforming the dining environment in long-term care communities. Participants will examine the physical, social, and operational factors that shape residents' mealtime experiences. This session will highlight best practices in meal service, staff-resident interaction, environmental design, and computer software that supports residents' dining experience.

**To Be or Not To Be, That is the Specialty Hospice and Palliative Care Certification Question** | Katie Huff- DNP; Aubrey Hensch, RN; Bethany Scarson, LPN; Michele Snyders, MSW; Carol Breitreutz, PharmD | CE: LNHA, SW

This interdisciplinary panel will present the current landscape of specialty certified hospice and palliative care healthcare professionals in South Dakota and the need to grow this specialty to make care for those living with serious illness more accessible in the state. Each discipline will speak to the process of becoming specialty certified and what organizations can do to encourage their teams to become certified.

**South Dakota Department of Health panel** | Shelly Walstead; Maurine Ford; and Carrie Christopherson | CE: LNHA, SW, CDM/CFPP

This panel will be presented by Public Health Advisors from the South Dakota Department of Health's Office of Licensure and Certification. The advisors will provide an overview of frequently cited infection control concerns identified during surveys of long-term care facilities, assisted living centers, and hospice/home health agencies. Attendees will gain insights into common compliance challenges and have the opportunity to engage in a Q&A session with the advisors.

**The Power of Systems Thinking in Healthcare** | Debbie Rayburn | CE: LNHA, SW

Lasting improvement in healthcare comes from a focus on redesigning systems vs. assigning blame. This session introduces systems thinking as a pathway beyond quick fixes, showing how process redesign drives meaningful change. Participants will explore Quality Improvement tools that support root cause analysis, while examining how theories of leadership, found in the 85/15 Rule and Deming's 14 Points for Leadership, provide a practical framework for building a culture of continuous improvement.

**Intentional Speaking: Communicating with Purpose and Impact** | *Danielle Pierotti, PhD, RN* | CE: LNHA, SW

Everyone talks all day. It is how we share information and build relationships. Talking is the root of bad feelings, mistakes, and conflicts. Talking is perceived as easy. It is not. Anyone who has ever felt misunderstood, surprised by someone's anger, or confused leaving a conversation knows this. We start to talk as toddlers, but when do we learn to communicate? Caregivers and leaders need to communicate in complex, sensitive, and evolving situations. Communicating with families and team members can be challenging. Navigating intergenerational workforce perspectives, rising family expectations, managing difficult conversations, setting boundaries, and building a positive, trusting relationship is all based on communication skills. This session will explore common communication pitfalls, practical strategies to improve effectiveness, and hands-on techniques to transform conflict into trust.

**Creative Aging Approaches for Care Teams** | *Ariadne Albright* | CE: LNHA, SW

This session provides a clear introduction to the national and rapidly growing field of Arts in Health, with a focus on how creative practices can support older adults across aging services. Attendees will learn best practices aligned with Creative Aging principles, including meaningful engagement, skill-building, social connection, and quality-of-life enhancement in residential and community-based settings. The session also includes a preview of a three-part Creative Aging SDAHO webinar series launching summer 2026. This series is designed to help caregivers, activities staff, and healthcare professionals integrate sustainable arts-based strategies into daily care routines.

**Working in Healthcare: The Natural Impact of the Work on Ourselves, Teams & Institutions** | *Vickie Leff* | CE: LNHA, SW, CDM/CFPP

It is expected that healthcare providers working in post-acute care will face challenges related to the emotional and psychological impact of their work. Recognizing occupational hazards such as empathic strain, burnout, secondary trauma, and moral distress helps validate provider experiences and allows us to tailor strategies that support long-term sustainability in healthcare. The question is not how to eliminate this impact, but how individuals, teams, and organizations can mitigate its effects to sustain both caregivers and the workforce as a whole. While the work will always be demanding, there is a shared responsibility to provide ongoing understanding, validation, and support in all its forms to ensure those doing this vital work can continue to thrive.

**From Visitor to Key Partner: Elevating Medical Leadership in Long-Term Care** | *Dr. Victoria Walker* | CE: LNHA

This session highlights how medical directors can maximize their impact in nursing homes through effective leadership, collaboration, and clinical oversight. Participants will explore strategies for building strong interdisciplinary relationships, meeting CMS requirements for antipsychotic and antimicrobial prescribing, and supporting compliance through appropriate documentation and ongoing evaluation. The session also covers practical approaches to quality improvement, including monitoring key indicators such as medication use, transfers, and vaccination rates, and applying tools like diagnostic stewardship, 72-hour antibiotic time-outs, and staff education to promote safe, evidence-based care.

**Rockin' the Future of Antibiotic Stewardship: Project STAMP Kickoff** | *Cheri Fast* | CE: LNHA

This session introduces Project STAMP, a statewide initiative designed to help long term care facilities enhance antibiotic stewardship through education and quality improvement. Attendees will learn how simple antibiotic tracking, tailored facility-specific education, and flexible focus areas can support each facility's stewardship priorities while improving resident safety.

**Strategies for Handling Turnover in Senior Living and Long-Term Care** | *Bob Lane* | CE: LNHA, CDM/CFPP

The senior living and long-term care industry continues to face unprecedented staffing challenges in the post-COVID landscape, leaving many organizations struggling to maintain essential operations across clinical, revenue cycle, and financial departments. Join the Forvis Mazars team as they share actionable strategies and best practices for developing robust contingency plans and operational safeguards. Whether you're navigating current staffing gaps or preparing for future transitions, this discussion will offer tools and insights to strengthen your organization's long-term sustainability.

**The Role of Guardians in Protecting Rights and Promoting Well-Being** | *Amy Hansen* | CE: LNHA, SW

This presentation will provide an overview of guardianship, including when it may be necessary, how the process is established, and the responsibilities involved in serving as a guardian. This workshop will present evidence-based support for the Debriefing strategy and provide practical guidance on implementing a Debriefing Program in your workplace to support staff well-being and resilience.

**Ensuring Compliance and Quality: Nursing Home Surveyor Process, Role, and Training** | *Rachel Luke, MS, RD, LN & Jennifer Maeschen, RN* | CE: LNHA, SW

This presentation provides an in-depth overview of the Long-Term Care Survey Process, highlighting its role in promoting regulatory compliance and quality of care in nursing homes. Attendees will gain insight into the responsibilities of surveyors as neutral third-party observers dedicated to objectively assessing facility performance. The session will also explore the comprehensive training required for new surveyors, which includes extensive field experience and completion of the federally mandated Surveyor Minimum Qualifications Test (SMQT). Emphasis will be placed on the standards that guide survey activities and the importance of consistency and integrity in the oversight process. This session is ideal for professionals seeking to understand the structure and significance of long-term care oversight.

**Dementia Communication Skills to Prevent Challenging Behavioral Symptoms** | *Erin Bonitto* | CE: LNHA, SW, CDM/CFPP

We often say that "It's all about the approach" when talking about dementia and behavioral care, but what does that really mean in daily practice? In this session, we'll break down clear, observable, proven communication skills that can be used to prevent frustration, reduce agitation, and help avoid behavioral symptoms before they escalate. Participants will hear from Erin Bonitto, a nationally known dementia communication coach. Erin will highlight known communication skills known to prevent and reduce the intensity of challenging behavioral symptoms in dementia care, with relevance for other cognitive and mental health differences as well. Participants can expect practical, real-world examples, and will learn how these approaches have been linked to measurable reductions in off-label antipsychotic use for persons with dementia in skilled nursing facilities – with lessons that can be applied in any setting where people living with dementia are served.

**Caution Ahead: Hot Point Compliance Issues in Home Health** | *Sean Fahey* | CE: LNHA

This session offers a current overview of the most pressing compliance challenges facing home health providers. The presenter will discuss recent enforcement trends and examine common operational risk areas, including medical director agreements and marketer payment arrangements. The session will highlight key issues arising in UPIC audits and address compliance pitfalls related to kickbacks involving discharge planners and case managers, offering attendees practical insights for navigating an increasingly complex regulatory landscape.

**Long Term Care Medicaid Eligibility & Assisted Living Tiers** | *Caitlin Clarey & Kristin McNeely* | CE: LNHA, SW

This session will provide an overview of the South Dakota Medicaid coverage groups and programs, general eligibility criteria, and facility cost shares. Information will also be presented on what goes into determining tiers for participants in an assisted living through the HOPE Waiver.

**It's Never Too Late, Until It Is - Creating Advance Directives** | *Michele Snyders; Dr. Amanda Sedlacek; Cameo Anders, JD, MA, CAP, CTFA* | CE: LNHA, SW

This panel presentation will feature a review of the four legally recognized advance directives in South Dakota. Case studies will be used to demonstrate when to complete, who can complete and why to complete to avoid ethical and legal dilemmas. **AI in Senior Living: Real Progress, Real Pitfalls, Real-Time Demos** | *Steven VanderVelde* | CE: LNHA, SW, CDM/CFPP

AI isn't just coming to senior living, it's already here. In this powerful session, we'll cut through the hype to show where AI is delivering measurable results and where it's falling short. You'll hear real stories from communities using tools like ChatGPT to improve documentation, resident engagement, marketing, and operations, alongside cautionary tales where blind trust in AI led to unintended consequences. Then, we'll take things to the next level with a live demo where ChatGPT joins the stage as an interactive participant, solving real-world challenges, answering tough audience questions, and revealing what it really means to lead in an AI-enabled future.

**Creating a Culture of All-Team Coaching for Dementia Care Excellence** | *Erin Bonitto* | CE: LNHA, SW

Too often, ongoing dementia education and coaching sit with a few "go-to" people instead of becoming part of the everyday habits of the whole team. This session looks at a different approach: building an all-team coaching culture where leaders, supervisors, and frontline team members across dining, housekeeping, maintenance, recreation, administration, and clinical care all play a steady, important role in sustaining excellence in dementia care. Through short, real-life snapshots, Erin Bonitto — a nationally recognized dementia coach — will share how brief coaching huddles and skill exercises, built into the fabric of daily routines, can fit into busy days with stretched staffing — and how to draw on the strengths of a multicultural, multilingual team while you do it. This fast-paced hour is designed for administrators, department leaders, dining services, nurses, social services, life enrichment, and interested frontline team members, and will offer practical ideas and sample coaching prompts to help you grow a deep bench of dementia-focused coaches back home.

**Solutions to Succeed with Managed Care in South Dakota** | *Susie Mix* | CE: LNHA

Managed care contracts continue to place increasing financial pressure on post-acute and long-term care providers. In this session, South Dakota operators of Skilled Nursing Facilities, Home Health agencies, Hospice agencies, and Assisted Living facilities will gain practical insights into how managed care business practices impact reimbursement and operations. Participants will explore proven strategies to optimize revenue, strengthen billing processes, and implement operational solutions that support long-term financial sustainability.
